All goods are supplied subject to the Terms & Conditions of The Little Bag Co. Please note the following points:-

1. Deliveries must be checked and signed for as having been received in good condition. Any shortage or damage must be noted together with the signature. Signatures with the remark "unexamined" are not acceptable. Claims for damage or pilferage must be made in writing within 3 days of the date of the invoice, and for non-delivery or short delivery, within 7 days of the date on our dispatch note or invoice.
2. All goods remain the property of The Little Bag Co until payment in full has been received by us. The risk in the goods shall pass from the seller (the Little Bag Co) to the buyer upon delivery of such goods to the buyer. However, notwithstanding delivery and the passing of risk in the goods, title and property in the goods, including full legal and beneficial ownership, shall not pass to the buyer until the seller has received in cash or cleared funds payment in full for all goods delivered to the buyer under all contracts between the seller and the buyer. Payment of the full price of the goods shall include the amount of any interest or other sum payable under the terms of any contract between the seller and the buyer under which the goods were delivered.
3. All prices shown exclude VAT where applicable.
4. The minimum order value we can work with is one carton. A delivery charge of £8.45 per carton is also applied to UK mainland – excluding AB,PK & highland postcodes, where the delivery charge is £13.99. For deliveries to Ireland, Isle of Man & channel Islands please contact us. Multiple cartons delivery charges vary and are available on request.
5. All descriptions and sizes are correct at the time of going to press, but we reserve the right to alter or amend specification without prior notice.
6. Payments can be made by BACS or cheque. Credit card payments incur 3% charge. Please allow 14 days for cheque payments to clear. Credit card payments have a 3% charge.
7. Payment is due NETT within 30 days of invoice date and prior to delivery. The Little Bag Co shall be entitled to charge interest at a rate of 2.5% monthly on overdue accounts.
